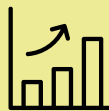
WAYS TO GIVE

CASH/CHECK



A gift of cash or check is a simple and easy way to make an immediate impact on TSA. Designate your gift to the Education Foundation. This allows you to take charitable income tax deduction on your year-end tax returns.

STOCKS AND BONDS



You can gift stock to TSA. The school can immediately sell the stock for a specific project or invest the proceeds of the sale into the endowment. By making a gift of appreciated securities, you can avoid paying capital gains tax that would otherwise be due if you sold these assets.

BEQUESTS



A bequest is one of the easiest gifts to make. With the help of an advisor, you can include language in your will or trust specifying a gift to TSA as part of your estate plan. A bequest can be made in several ways:
